#### Evaluation of the tenders

The "Bid B" of those Bidder failing to meet the technical & other requirements of participating in the tender will not be opened and be rejected. The Bidder offering the item found suitable and as being as per the tender specifications will only be selected.

The Bidder who have been so identified to have been technically suitable in the context of above will be deemed to have passed the test of essential and other requirement of the quoted item or items.

If found suitable in the context of above pre qualification etc, the Bidder quoting the highest discount rate will be considered as successful.

#### **GENERAL TERMS & CONDITIONS**

#### (Annexure - I)

- 01. Tender shall remain open for acceptance for a period of 120 days from the date of opening of Tender.
- 02. Tenderer should quote the rate of discount (in percentage) offered on publishers' printed rate. The TIA is not bound to accept the highest discount or any other tender and also reserve the right of rejecting all or any of the tender without assigning any reason thereof.
- 03. The current bank exchange rate (TT Selling Rato) on the date of purchase order for Medical Books shall be used for conversion of foreign currencies. All payment will be made in Indian Rupees only.
- 04. Net payable price will be publishers' printed price or (in case of price in foreign currency) equivalent price in INR minus discount offered.
- 05. The invoice raised against supply should bear certificate from the supplier that Medical Books of latest edition is supplied and the price has been charged correctly in accordance with the price list of the publishers.
- 06. The Medical Books available in India will be supplied within 30 days from the receipt of the purchase order. In case foreign books supplies should be completed within 45 days from the receipt of purchase order. Delivery will be made at DNB, M R Bangur Hospital, 241 Desh pran Sashmal Road, Kolkata 700 033 without charging any delivery cost.

- 07. Medical Books will be accepted only after the inspection by the Librarian/concerned authority.
- 08. The Bid E.M.D. will be forfeited if :
  - a. The bidder withdraws his bid during the period of bid validity.
  - b. The successful bidder fails or refuses to honour his/her/their own quoted prices for the specified services or part thereof.
- 09. All rights are reserved with The Superintendent, M R Bangur Hospital, Tollygunge, Kolkata to accept or reject all the Tender without assigning any reasons thereof.
- 10. Conditional or incomplete tenders will not be accepted. Canvassing of any kind, direct or indirect, shall lead to disqualification of the tenderer.
- 11. Payment shall be released to the firm within 15 days from the date of successful delivery, demonstration and commissioning of the machine and submission of invoice along with warranty card.
- 12. The Superintendent, M R Bangur Hospital bears the legal and financial responsibility of any litigation arises in the tender procedure.

- 16. The purchase order will be issued based upon the requisition from the concerned department. The tendering authority bears no obligation to issue purchase order.


