




## General Terms & Conditions

- 1) Time of Completion-**45 Days** from the day of receipt of work order.
- 2) It may please be noted that all documents that comprise the tender documents should be signed and sealed by the tenderer.
- 3) No part of the bill of quantities/ financial bid including specifications should be deleted.
- 4) Defects liability Period: **06 months** from the date of completion.
- 5) Superintendent, M R Bangur Hospital reserves the right to accept or reject any /all tender/s in part or whole of any firm /firms without assigning any reasons for doing so.
- 6) EMD : Rs.5,000/- (Demand Draft in favour of Superintendent, M R Bangur Hospital, Kolkata ) (Local SSI (s)/ MSME situated in West Bengal should furnish certificate of registration for claiming EMD exemption.)
- 7) This Tender shall not include any conditions whatsoever. In case any conditions are included in the tender, the same shall not be taken into consideration. Further, the tender in such case is liable to be rejected.
- 8) Tenders received late on account of any reason whatsoever and telegraphic and faxed/post tenders shall not be entertained.
- 9) Rates should be quoted both in figures and words in columns specified. All erasures and alterations made while filling the tender must be attested by initials of the tenderer. No advice of any change in rate or conditions after the opening of the tender will be entertained.
- 10) Each of the tender documents should be signed by the person or persons submitting tender in token of his/their having acquainted himself/themselves with the General Conditions of Contract, Specifications, and Special Conditions etc. as laid down.
- 11) The contractor shall not assign the Contract to other agency. He shall not sublet any portion of the Contract except with the written consent of the authority.
- 12) Time allowed for carrying out the work as mentioned in the Memorandum shall be strictly observed by the Contractor. Otherwise the contract will be cancelled, EMD will be forfeited.
- 13) The Employer will provide water and power required for the work free of cost at a suitable point and the contractor shall make his own arrangement to carry the same as required. The Contractor should ensure that the water and power facility provided by the Employer are not wasted.
- 14) The Contractor shall provide everything necessary for the proper execution of the works according to the intent and meaning of the Schedule of Quantities.
- 15) Adequate precautions shall be taken to prevent danger from electrical equipment. No material on the site of work shall be so stacked or placed as to cause danger or inconvenience to any person or the public.




- 16) The Works shall not be considered as completed until the competent authority has certified in writing that they have been completed.
- 17) The Contractor shall be responsible for all injury to persons, animals or things, and for all structural and decorative damage to property which may arise from the operation or neglect of himself or damages arising from carelessness, accident or any other cause whatever in any way connected with the carrying out of the Contract.
- 18) Rate to be quoted against any item in the Schedule of Quantities shall be inclusive of all the materials, labour, equipment, facilities and direct and indirect overheads for safe and timely completion of item in accordance with the specifications.
- 19) Quantities will be allocated for various items are based on general requisition received time to time from different units and wards. Variations to any extent are possible during actual execution for individual items as well as for whole work. WO will be issued in phased manner as per necessity of the hospital.
- 20) Rate quoted by the contractor shall include for removal of debris out of premises, removing stains and cleaning the site thoroughly and unless the same is done to the satisfaction, the bill will not be settled.
- 21) Workmanship should be of high quality, else, no payment shall be made.
- 22) Bidders have to submit their bid in prescribed form (Annexure – I) attached herewith.
- 23) Accepted rate will be valid for 02 years.
- 24) In case of unsuccessful bidders, the EMD will be refunded only on award of Contract to the successful bidder. If the bidder withdraws his tender before expiry of the validity period of the tender or if the Contractor fails to execute / complete the works satisfactorily, Superintendent, M R Bangur Hospital reserves the right to forfeit the EMD.
